It is therefore to be noted that although the strength of GC members based on the membership strength of Mumbai Branch **1467** is 3, of which election for GC members used to be for 3 members only.

**NOW in view of the above resolution, the Mumbai Branch will allot the Chairman of Navi Mumbai Chapter as one of the GC Member. The election of GC members for Mumbai Branch will be therefore be only for 2 members.**
