- Policies including incentives, financial solutions etc. for transition of domestic shipping to achieve above identified targets.
- Achieving Green ports through JIT, Shore power and promoting bunkering infrastructure at Ports through Green Corridors (identify suitable ship types, ports, and ships for developing initially such corridors)
- India's stand at IMO on issues related to MBM, GHG ambition, intermediate reduction targets.

D.G.SHIPPING - INMARCO Green Shipping Conclave



- Session 1: Discussions to establish the Availability of Alternate Net Zero/Zero Carbon Fuel in India. Discussions will cover the quantity which can be made available for shipping and the cost - not only addressing the domestic maritime sector but also the vision of being a supplier for international market for green fuel (bunkering hub).
- 2) Session 2: Exploring the Alternate Technologies and solutions for existing ships and new ships of various types keeping in mind their operational profile. Thus cover all types of ships including tugs, passenger ships on short run, barges, offshore vessels etc. Also cover the cost aspect of such conversions / upgradations.
- 3) Session 3: Readiness for Construction of Green Ships and Fitment of the Alternate Technologies as identified in India. The availability of the shipyards both wrt facilities and technology to be explored alongwith considering timeline wise efficient and costwise effective solutions. Thus to identify how the shipyards can support such transition and what necessary developments needs to be identified to reduce cost of such transition.
- 4) Session 4: This session will be Port based developments identifying the potential of Ports in decreasing cost of transition of ships to net zero through services such as JIT, Shore Power Supply and higher efficiencies. Further discussing regarding developing necessary infrastructure for various types of fuels. Group will also deliberate on Green Corridors.
- 5) Session 5: This session will cover the aspect of Financing Green Shipping in India identify investment needs and sources to cover additional onetime cost of transition and higher operational cost.
- Constant Discussions between **Policy makers**, **Invitees and Stakeholders** in the above sessions with the participating experts.
- The report of **DNV under India Norway Coastal Shipping program** will also be presented at this session.
- Concluding session 19th Nov: Policymakers, Invitees and Chairpersons of the five sessions deliberate on the report from the 17th Nov session and lay the foundation for Formulation of Green Shipping Policy and the way forward.
