- **2.** To claim the Input Tax Credit on the online GST portal immediately or within the deadline

Upon claiming the ITC, the sum of INR 18,03,789/- shall be retained by IME(I) in its credit ledger and shall strictly remain unutilised and will be reversed immediately in the next month with no penalty or interest will be levied on IME(I) on such reversal. And despite the reversal, IME(I) having made a timely claim, shall have a cause of action to claim the ITC from the GST department after Sahara Star makes the actual payment in the future as advised by the legal advisor and GST consultant .
