**COURSES OFFERED AT IMEI, KOLKATA BRANCH  
MODULAR COURSES**

**➤ Basic Training for Ships using Fuels covered within IGF Code-(5 days)- Course ID-5311**

**Eligibility**

1. Any seafarer who has completed the four Basic safety courses, under STCW Regulation VI/1 and Section A-VI/1.
2. Seafarers holding Basic or Advanced Level Gas Tanker Cargo endorsement / COP are not required to undertake this training.

**Documents Required**

1. Four Basic Safety Courses Certificates
2. Valid Medicals from a D.G.Shipping Approved Doctor
3. INDoS and Passport

**PPE Required for firefighting practical**

1. Boiler Suit
2. Safety Shoes

➤ **Crisis Management & Human Behaviour-(5 days)- Course ID-5212**

**Eligibility**

This course is open to masters and officers (management and operational levels), holding appropriate certificates of competency, who will be serving on passenger ships and also those already serving on passenger ships and have not done this course before.

**Documents Required**

1. B-SID
2. INDoS Number

➤ **Crowd management, Passenger Safety and Safety Training-(3 days)- Course ID-5211**

**Eligibility**

This course is open to ratings and other personnel (support level) who will be serving on a passenger ship and also those already serving on passenger ships and have not done this course before.

**Documents Required**

1. Proof of six months Sea Service vide CDC/Passport/Service certificate
2. INDoS Number is mandatory
3. Passport, CDC, Certificate of Competency

\*B-SID is not applicable for freshers. It is mandatory for all seafarers with CDC

➤ **Security Training for Seafarer with Designated Security Duties-(2 days)- Course ID-6621**

**Eligibility**

1. This course is open to all Seafarers
2. INDOS no is mandatory.
3. B-SID is not applicable for freshers. It is mandatory for all seafarers with CDC

**Documents Required**

1. INDoS Number
2. Passport

➤ **Ship Security Officer-(3 days)- Course ID-6511**

**Eligibility**

Those attending this course shall have approved seagoing service of not less than 12 months or appropriate seagoing service and knowledge of ship operations; and are likely to be designated as Ship Security Officer.

**Documents Required**

1. INDoS and CDC with a proof of 12-month sea service
2. Passport
