1) Security Training for Seafarers with Designated Security Duties [2 Days], Course ID-6621

#### **Eligibility**

- 1. This course is open to all Seafarers
- 2. INDOS no is mandatory.
- 3. B-SID is not applicable for freshers. It is mandatory for all seafarers with CDC

## **Documents Required**

- 1. INDoS Number
- 2. Passport
- 2) Ship Security Officer [3 Days], Course ID-6511

#### **Eligibility**

Those attending this course shall have approved seagoing service of not less than 12 months or appropriate seagoing service and knowledge of ship operations; and are likely to be designated as Ship Security Officer.

- 1. INDoS and CDC with a proof of 12-month sea service
- 2. Passport

3) Basic Training for Ships Using Fuels Covered with IGF Code [5 Days], Course ID-5311

#### **Eligibility**

- 1. Any seafarer who has completed the four Basic safety courses, under STCW Regulation VI/1 and Section A-VI/1.
- 2. Seafarers holding Basic or Advanced Level Gas Tanker Cargo endorsement / COP are not required to undertake this training.

#### **Documents Required**

- 1. Four Basic Safety Courses Certificates
- 2. Valid Medicals from a D.G.Shipping Approved Doctor
- 3. INDoS and Passport

#### PPE Required for fire fighting practical

- 1. Boiler Suit
- 2. Safety Shoes
- 4) Basic Training in Oil and Chemical Tanker Cargo Operations [6
  Days], Course ID-5111

### **Eligibility**

1. This course is principally intended for candidates for certification for basic training for oil and chemical tanker cargo operations as specified in section A-V/l-l para 1 of the STCW Code as amended.

2. The trainees shall have successfully completed approved Basic Safety Training course as per STCW Section A - VI/I, para 2, 31 Tables A - VIM-I, A- VI/1-2, A- VI/1-31 A - \/1/1-4.

- 5) Basic Training in Liquified Gas Tanker Cargo Operations [5 Days],

#### **Eligibility**

- 1. This course is principally intended for candidates for certification for basic training for gas tanker cargo operations as specified in section A,,V/1-2 para 1 of the STCW Code as amended.
- 2. The trainees shall have successfully completed approved Basic Safety Training course as per STCW Section A-VI/1, para 2, 3, Tables A VI/I-II A -21 A- \/ 1/1-3, A VIM-4.
