

COURSES AT IME(I) KOCHI

Competency Courses

1) MEO Class I Preparatory Course (2 months) , Course id – 3231

Eligibility:

- Every candidate shall have approved sea-going service as appropriate for motor/ steam in the engine department of sea going ship as Engineer Officer in charge of an Engineering watch on ships of 750 kW or more for a period of not less than 36 months which shall include not less than 12 months as holder of certificate of competency as Marine Engineer Officer Class II on ships powered by main propulsion machinery of 3000 kW propulsion power or more.
- However, in such cases the period of 36 months shall be reduced to 30 months, i.e. if 12 months of such sea-going service as appropriate for motor/ steam in the engine department of sea going ship has been served as Second Engineer Officer on a seagoing ship powered by main propulsion machinery of 3,000 kW propulsion power or more, or pro rata.

2) MEO Class II Preparatory Course (4 months) , Course id – 3211

Eligibility:

- Every candidate shall have not less than 12 months approved sea-going service as appropriate for motor/ steam in the engine department of sea going ship as a qualified Engineer Officer on ships of 750 kW or more.

Modular Courses

3) Refresher & Updating Training for All Engineers (3 days) , Course id – 1118

Eligibility:

- For all Engineer Officers (Operational and Management Level) whose CoC is already in compliance with STCW 2010 amendments and aspiring to revalidate CoC.

4) Vertical Integration Course for Trainers (VICT) (10 days) , Course id – 1061

Eligibility:

- The course is designed for individuals who are to qualify as Trainers and Assessors for conduct of courses approved by the Directorate General of shipping.
- Trainers wishing to deliver training in the competence standards required by the STCW Convention and Code should already have the necessary technical knowledge and be qualified for the task for which training is to be conducted. It is assumed that the course trainees are appropriately qualified in the technical aspects of their subjects.
- The technical qualification required for conducting DG-approved courses is mentioned in the individual course guidelines General guidance of faculty requirements is given in DGS Order 5 of 2016
- All candidates should have INDoS number.

5) Assessment Examination and Certification of Seafarers (AECS) (10 days), Course id: 1062

Eligibility:

- Every candidate qualified to conduct assessments and examinations of seafarers for certificates of competency issued in accordance of the STCW convention, 1978, as amended should possess a certificate of competency no lower than the certificate or qualification, which he/she is to examine and certify on behalf of the Directorate General of Shipping
- Shall hold a Certificate of Competency, issued by the Govt of India" or equivalent, either as · Master (FG) or · MEO Class I (FG) or · ETO or · GMDSS (GOC) And
- Hold a certificate for "Training Course for Trainers and Assessors", (TOTAL / VICT)
- Have Fluency (both spoken and written) in the language in which the course will be conducted
